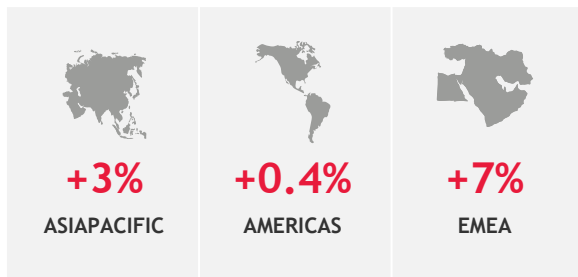

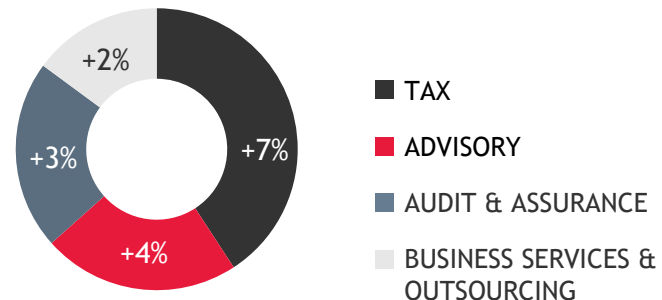

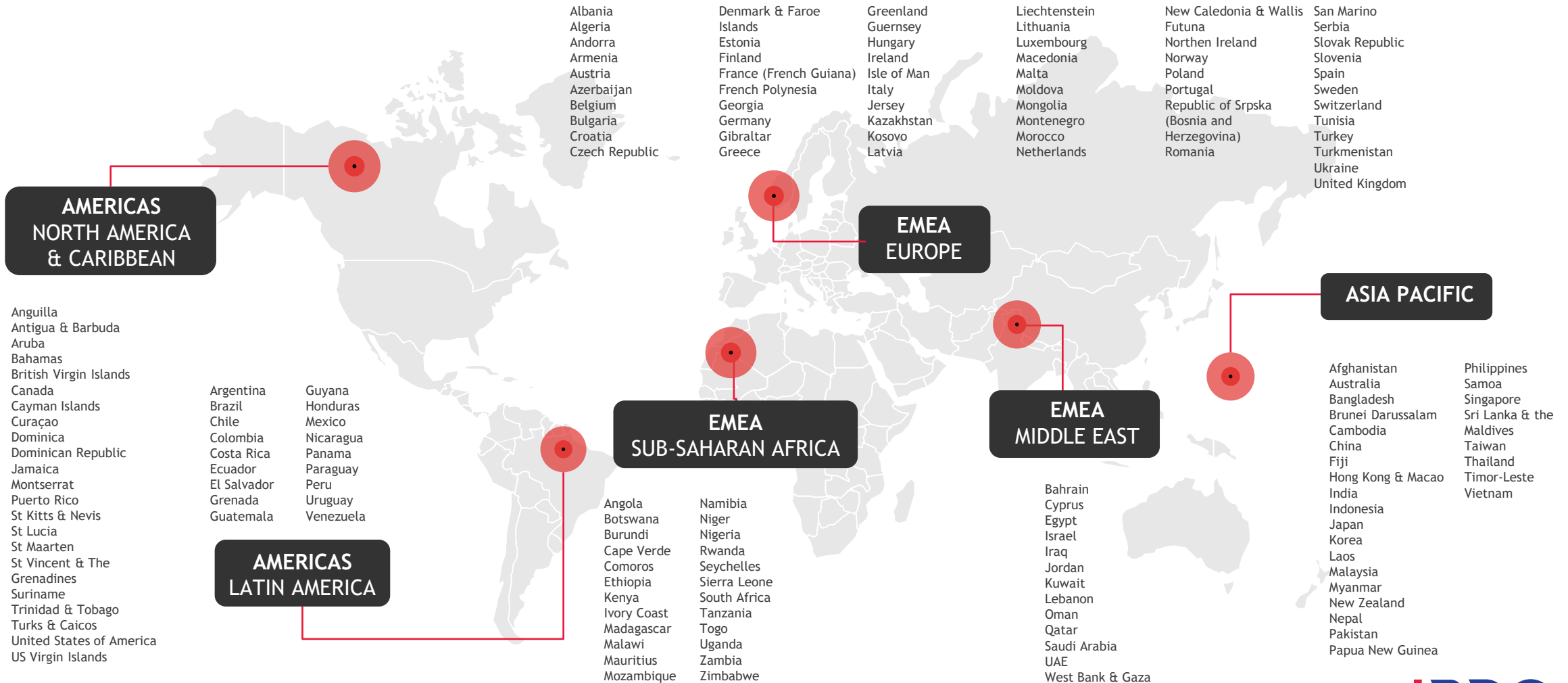


GROWTH BY SERVICE LINE

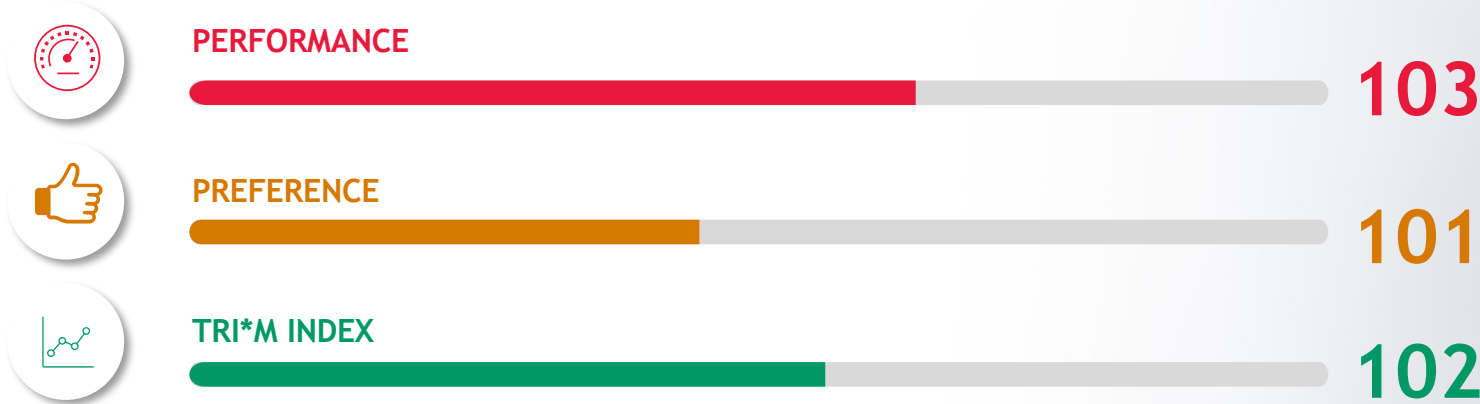
